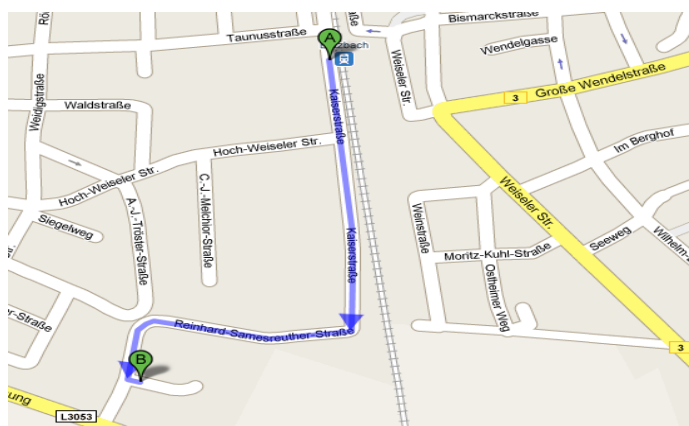

### **Journey by the train / footpath 0.8 kms - circa 9 minutes:**
